CIRCULAR

It is hereby informed to all concerned that in view of implementation of the 'Ease of Doing Business' for providing efficient, convenient, transparent and integrated electronic services to the applicant, the West Bengal Pollution Control Board (WBPCB) has rearranged the fees collection system.

As per the revised system, all kinds of application fees payable to the WBPCB shall be deposited by the industries / establishments, after submitting online application and getting system generated challan from the Online Consent Management & Monitoring System (OCMMS) [http://wbocmms.nic.in] developed by NIC. Payment can be made through online payment system i.e. i) through Net Banking; ii) through debit card / credit card / NEFT / RTGS.

In online payment system, the present transaction charges required to be paid by the industries / establishments along with payment of all kind of fees is given below:-

SI.	Mode of Payment	Transaction Charges
1	Payment through Debit Card	 i. NIL Per Transaction below Rs.2000/- ii. 1.00% of Transaction Value plus GST Per Transaction above Rs.2000/-
2	Payment through Credit Card	1.00% of Transaction Value plus GST Per Transaction.
3	Payment through Net Banking	Rs.10/- Per Transaction.
4	RTGS & NEFT	Rs.5/- Per Transaction.

These transaction charges are liable to change subject to modifications by the competent authority.

The online payment system is implemented for Consent to Establish, Consent to Operate, Hazardous Waste Authorization, Bio-Medical Waste Authorisation and E-Waste Authorisation.
