CIRCULAR

In compliance of the requirements of 'Ease of Doing Business Programme' and 'Reduction in Regulatory Compliance Burden on Industries Programme' of the Government, West Bengal Pollution Control Board (WBPCB) made it mandatory for submission of applications for various services (Consent to Establishment (CTE), Consent to Operate (CTO), Authorisation Registration etc.) through Online Consent Management & Monitoring System (WBOCMMS) only. Payment of fees for those services are also made through online payment gateway of ICICI Bank only.

Now, it has come to the notice of the Board that few Project Proponents has made payment of such fees to Punjab National Bank (PNB) A/C of WBPCB and such payments do not reflect in WBOCMMS. Therefore, WBPCB could not process those online applications.

The WBPCB has considered the issue of payment of such fees made by the Project Proponents wrongly to Punjab National Bank (PNB) and it has been decided that on receiving prayer from the project proponent for refund of such payment of fees made through PNB, concerned Regional Office(s) / Cells of the Board shall recommend for refund of payment after necessary verification to the Accounts Section of the Board. Accordingly, concerned officer of the Accounts Section, WBPCB dealing with CTE / CTO & other fees, shall refund payment to the project proponent after necessary scrutiny, through A/C.Payee Cheque / online.

Concerned Regional Office(s) / Cells of the Board shall ensure that all those project proponents must deposit payment of fees through Online Consent Management & Monitoring System (WBOCMMS) & ICICI Bank payment gateway.
