ORDER

In recent times The West Bengal Pollution Control Board (WBPCB) is receiving proposals for setting up of Microbreweries / Craft Beer Manufacturing. These are mostly being located in urban areas or inside busy commercial or business complexes.

Now in consideration of existing order of categorization of WBPCB vide Memo No. 1512/4A-18/2010 (Pt.I) dated 14.06.2016 and in consideration of existing “**Industrial Siting / Locational Policy in West Bengal**”, the WBPCB has decided to include Microbreweries /Craft Beer Manufacturing under **ORANGE** Category in Sl. No. 38 :

“Hotels (<3 star) or hotels having >20 rooms and <100 rooms having waste-water generation <100 KLD and >10 KLD, and / or having boiler / heater / oven etc. [including restaurants with capital investment on land, building, plant and machinery >30 lac]”

Sl. No. 38 of ORANGE Category shall be substituted by the following item :

“Hotels (<3 star) or hotels having >20 rooms and <100 rooms having waste-water generation <100 KLD and >10 KLD, and / or having boiler / heater / oven etc. [including restaurants with capital investment on land, building, plant and machinery >30 lac and/or Microbreweries /Craft Beer Manufacturing]”

All such units shall obtain the Consent to Establish / Consent to Operate from the WBPCB.

This order will take immediate effect.
