## **ORDER**

WHEREAS, the West Bengal Pollution Control Board had introduced dashboard related reforms under 'Ease of Doing Business' to bring transparency in information dissemination and to help applicants know the minimum time in which their applications will be approved and system generated certificates will be issued through the Consent Management & Monitoring System (WBOCMMS), developed by NIC, Delhi for all services rendered by the Board.

**AND WHEREAS,** Department for Promotion of Industry and Internal Trade, Government of India, has recommended to modify and develop a smart Dashboard having also the provision to further drill down for displaying application details.

NOW THEREFORE, the West Bengal Pollution Control Board, Department of Environment, Government of West Bengal has decided to modify the existing online dashboard for all services it renders displaying the particulars such as time limit as prescribed under WBRTPS Act; number of applications received; number of applications approved; average, median, minimum and maximum time taken to obtain approval and also average fees paid by the applicant for availing of a particular service. The dashboard will also have the utility to further drill down and display date-wise and application-wise details like application number and date, approval date, total fees paid by the applicant with break-up. The online dashboard will have to be updated on real time and will reflect date and time of information updation.
